1 Beautification, All -

Pending Business:

- Garages and outbuildings ordinance: Commissioner Ajwah forwarded ordinances of an adjacent township (Crockery) ahead of the meeting, and went over his notes and observations of what he considers relevant to the issue before the Planning Commission. Commissioner Ajwah recommended going through the ordinances for Crockery, Fruitport and Spring Lake Townships ahead of the next PC meeting in January to come up with a recommendation for amending the Village's ordinance, while at the same time taking into consideration that most of the lot sizes within most of the zones in the village ordinances are smaller (compared to the different respective zones in the townships) when developing recommendations for lot coverage percentages and buildings to lots ratios.
- Art Ordinance Amendment: The Planning Commission will start reviewing Muskegon and Kent counties Art ordinances ahead of developing a recommendation for the Village's ordinances.
