- 1. Call to Order The meeting was called to order by President Vanderstelt at 5:00 p.m.

- 3. Consent Agenda The consent agenda includes the November 17 2025 Council Meeting Agenda, October 20, 2025 Council Meeting Minutes, and Payment of Bills.
